THIS AGREEMENT made the DDth day of MM, YY between **Rural Power Company Ltd.**, House: 19, Road: 1/B, Sector: 09, Uttara Model Town, Dhaka-1230, Bangladesh (hereinafter called "the Purchaser") of the one part and **GE Global Parts & Products GmbH,** Brown Boveri Strasse 7, 5400 Baden, Switzerland (hereinafter called "the Supplier") of the other part:

WHEREAS the Purchaser invited Tenders for certain goods and related services, viz, Procurement of Materials for Rewinding of GT-1 Generator Stator at Mymensingh Power Station and has accepted a Tender by the Supplier for the supply of those goods and related services in the sum of \$ 4,20,000 (Four Hundred Twenty Thousand US Dollars) (hereinafter called "the Contract Price").
