THIS AGREEMENT made the DDth day of MM, YY between **Rural Power Company Ltd.**, House: 19, Road: 1/B, Sector: 09, Uttara Model Town, Dhaka-1230, Bangladesh (hereinafter called "the Purchaser") of the one part and **Ramakrishna Electrical Winding Works**, Door No. 69-4-2/1, Opp. Boat Club, Pithapuram Road, Kakinada-533003, Andhra Pradesh, India (hereinafter called "the Supplier") of the other part:

WHEREAS the Purchaser invited Tenders for certain goods and related services, viz, Procurement of Materials and Related Services for Rewinding of GT#4 Generator Rotor at Mymensingh Power Station and has accepted a Tender by the Supplier for the supply of those goods and related services in the sum of \$ 191,000 (One Hundred Ninety One Thousand US Dollars) + & 8,700,000 (Eight Million Seven Hundred Thousand Taka) (hereinafter called "the Contract Price").

3. In consideration of the payments to be made by the Purchaser to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Purchaser to provide the goods and related services and to remedy any defects therein in conformity in all respects with the provisions of the Contract.

The Purchaser hereby covenants to pay the Supplier in consideration of the provision of the goods and related services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
