
You are thus requested to take following actions:

## Contract Agreement (Draft)

THIS AGREEMENT made the DD<sup>th</sup> day of MM, YY between **Rural Power Company Ltd.**, House: 19, Road: 1/B, Sector: 09, Uttara Model Town, Dhaka-1230, Bangladesh (hereinafter called "the Purchaser") of the one part and **GE Global Services GmbH (GEGS)**, Brown Boveri Strasse 7, 5400 Baden, Switzerland (hereinafter called "the Supplier") of the other part:

WHEREAS the Purchaser invited Tenders for certain goods and related services, viz, Procurement of Related Services for Rewinding of GT-1 Generator Stator at Mymensingh Power Station and has accepted a Tender by the Supplier for the supply of those goods and related services in the sum of **\$ 5,96,757.00 (Five Hundred Ninety Six Thousand Seven Hundred Fifty Seven US Dollars) including VAT & AIT** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the General Conditions of Contract hereafter referred to.
2. The following documents forming the Contract shall be in the following order of precedence, namely:
  - (a) The signed Form of Contract Agreement.
  - (b) The Notification of Award.
  - (c) The Tender and the appendices to the Tender.
  - (d) Particular Conditions of Contract.
  - (e) General Conditions of Contract.
  - (f) Technical Specifications.
  - (g) Drawings.
  - (h) Price Schedules and Schedule of Requirements and
  - (i) Other document including correspondences listed in the PCC forming part of the Contract.
3. In consideration of the payments to be made by the Purchaser to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Purchaser to provide the goods and related services and to remedy any defects therein in conformity in all respects with the provisions of the Contract.
4. The Purchaser hereby covenants to pay the Supplier in consideration of the provision of the goods and related services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
